Community Choice Digital Wallet Vacation Giveaway

OFFICIAL RULES

The Giveaway shall be subject to these Official Rules, and by entering, all entrants agree to abide and be bound by the terms and conditions herein and the decisions of the Sponsor.

Your contact information must be accurate in order for your entry to be eligible.
