



COMMUNITY CHOICE Road Rally GIVEAWAY OFFICIAL RULES NO PURCHASE OR TRANSACTION NECESSARY TO ENTER OR WIN. A PURCHASE OR TRANSACTION WILL NOT IMPROVE YOUR CHANCES OF WINNING.

This Giveaway starts at 12:01 A.M., January 6 2025 and ends at 11:59 P.M., December 13, 2025("Entry Period"). The sponsor of this Giveaway is Community Choice Credit Union, 31155 Northwestern Hwy, Suite 294, Farmington Hills, MI 48334 ("Sponsor"). The Giveaway shall be subject to these Official Rules, and by entering, all entrants agree to abide and be bound by the terms and conditions herein and the decisions of the Sponsor.

1) **How to enter:** You must be a consumer member with a share-account (share) in good-standing of Community Choice Credit Union who utilizes the e-Banking platform to enter ("Player"). Membership is subject to the Community Choice Membership Agreement, which is incorporated herein by reference. Contest entry is free of charge. All entries must be received during the applicable Entry Period. Limit two (2) entries per person per Entry Period; additional entries from the same person during the same Entry Period will be disqualified. Your contact information must be accurate in order for your entry to be eligible. Incomplete entries will be disqualified, and the Released Parties (defined below) are not responsible for entries that are lost, late, deleted, garbled, misdelivered, or misdirected as a result of technical, internet or other online difficulties. All received entries become the property of Sponsor and will not be returned. Sponsor will treat entry information in accordance with its privacy policy. Any attempt by any entrant to obtain more than the stated number of entries using multiple/different e-mail addresses, identities, registrations and logins, or any other methods will void such entries and that entrant may be disqualified.

Players travel along a digital gameboard, advancing as they correctly answer a weekly question and/or earn badges for selected activities. Drawing Entries are earned at two pre-determined checkpoints within the game. The Road Rally Giveaway is available exclusively for consumer members.

- At the various intervals, activity badges available to be earned will be replaced by five new activity badges. Limit of one badge earned per day.
- Sponsor reserves the right to release unannounced opportunities to earn badges and nonmonetary incentives.

2) **Eligibility:** The Road Rally Giveaway is open to legal U.S. residents who are consumer members of Community Choice Credit Union ("Members") who are eighteen





(18) years of age or older as of the first day of the Entry Period. Community Choice Board of Directors are not eligible for any monetary prizes. Employees, along with accounts they are joint on, are not eligible to win the three grand prize drawings of \$1000.00, \$500.00, and \$250.00, but are eligible for ingame incentives (game piece upgrades, etc.) and the \$10.00 and \$25.00 share deposit prizes. A potential winner may be requested to provide the Sponsor with proof that the potential winner is the member associated with the winning entry and that all eligibility requirements are met. Void where prohibited. This Giveaway shall be governed and enforced pursuant to Michigan law, excluding choice of law provisions.

- 3) Selection of Winners/Odds/Notification: The Winner will be selected at random during a drawing to take place on or about December 17, 2025 from among all eligible entries received for the Entry Period. Odds of winning depend on the number of eligible entries received during the Entry Period. Sponsor will attempt to notify the potential winners using the information provided in the entry form on or about December 17, 2025. A potential winner will be disqualified, the prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential winner may be selected by random drawing from among all remaining entries if: (1) any potential winner cannot be contacted or does not respond within one (1) week of the time of the issuance of prize notification; (2) any potential winner does not fulfill the eligibility requirements; (3) a winner does not adhere to the Official Rules; and/or (4) if the prize notification is declined or returned as undeliverable or refused.
